At the booking, you will have to pay the cancelling insurance (unrequired), the booking fees and the advance of 30%. The balance of the stay must be paid 1 month before the arrival. I will pay this balance 30 days before the arrival the/...../2018.

GENERAL CONDITIONS OF BOOKING

CAMPING PITCH

The booking of a camping pitch involves the signature of the booking form and the payment of a deposit of 30 % of the total price, the reservation fees and the cancelling insurance (optional). **BE CAREFUL** : No check are accepted less than one month before the arrival. The balance of the stay is to be paid one month before the arrival without any reminder from the campsite.

Payments accepted are money order, bank transfer or credit card. Any booking is nominative, it is forbidden to sublease or to give the pitch to anyone not predicted on the contract. The booking is definitive at the moment the campsite sends a written confirmation that must be brought at the arrival. In case of lateness and without news from the client 24h after the planned date of arrival, the campsite management reserves the right to take disposal of the pitch. The payments done will be kept. In case of cancelling or interruption of the stay no refund will be possible except if the client has subscribed the cancelling insurance with the insurance company "Campez Couvert", Gritchen Affinity, Insurance society, ORIAS 11061317, phone 02.48.65.93.95, fax 09.56.24.32.33, RCS Bourges, loisirs assurances.com, from which have transmitted to the client the cancelling modalities.

The camping pitch is at the disposal from 2PM and has to be freed before 12 AM the day planned. Maximum 6 people per pitch. The pitch is rented per night.

RENTALS :

The booking of a rental (cottage or bungalow toilé) involves the signature of the booking form and the payment of a deposit of 30 % of the total price, the reservation fees and the cancelling insurance (optional). **BE CAREFUL** : No check are accepted less than one month before the arrival. The balance of the stay is to be paid one month before the arrival without any reminder from the campsite. Payments accepted are money order, bank transfer or credit card. Any booking is nominative, it is forbidden to sublease or to give the pitch to anyone not predicted on the contract. The booking is definitive at the moment the campsite sends a written confirmation that must be brought at the arrival. You must inform of any change on the contract one month before the planned arrival.

Each rental is fitted for the number of people corresponding to the number of beddings (mentioned in the description). It is forbidden to exceed the number of people registered on the signed booking contract (any person not mentioned on this contract will not be allowed in the

rental or pitch). Installations on the pitches are only allowed with the agreement of the campsite management.

In case of lateness and without news from the client 24h after the planned date of arrival, the campsite management reserves the right to take disposal of the pitch. The payments done will be kept. In case of cancelling or interruption of the stay no refund will be possible except if the client has subscribed the cancelling insurance with the insurance company "Campez Couvert", Gritchen Affinity, Insurance society, ORIAS 11061317, phone 02.48.65.93.95, fax 09.56.24.32.33, RCS Bourges, loisirs assurances.com, from which have transmitted to the client the cancelling modalities.

In low season, rentals are possible for a week and two nights at least. The hours of arrival can change with the agreement of the management.

In high season, the bookings are from Saturday to Saturday or Wednesday to Wednesday, from 3 PM and departures before 10 AM. A guarantee of 260 € will be obligatory the day of the arrival **only by credit card** (not cashed), 200 € to cover potential deterioration and 60 € for cleaning.

The guarantee will be returned the week after the departure, after the checking of the rental done the day of departure.

Inventories which are not returned the day after the arrival will not be considered. The checking will then be made with the one left by the previous client.

Only animals less than 10 kg are tolerated with extra charge (**forbidden in Premium range**). The vaccination card is obligatory. **1st and 2nd category of dogs are not allowed.**

EXTRA CHARGES :

- Wellness chalet access
- WIFI access by prepaid cards
- Washing and drying tokens
- Cleaning forfait 60 €
- Fridge, baby cot, high chairs (subject to availabilities)

OTHER INFORMATIONS :

All prices include all taxes with a VAT rate of 10% practicable the day it is determined. Any later change of the VAT rate between the moment of the prices creation and the billing of the stay, will involve a change of the all tax included price, which the client accepts.

No refund will be allowed if the rules and regulations are not respected (noise, dangerous behaviour, drunkenness ...)

Clients who did not inform the office of their late arrival, after the closing of the reception, and not completed contracts will only be able to access to the campsite the next day.

Any person staying in Camping Beaulieu engages himself to respect the rules and regulations posted at the entrance of the campsite.

Animals must be held on a lead. Clients must behave like a responsible owner, return a clean rental clean and pick up the droppings.

Visitors are welcome but must register at the reception. Their vehicle will have to park on the entrance parking. They are under the responsibility of the campers who receive them and must pay extra charge for more than two hours of visit.

Charcoal barbecues are forbidden on pitches according to a prefectural decree.

Children must be accompanied by an adult at the swimming area. Shorts and bermudas are forbidden, only swim suits are authorized. At the arrival, the client will receive a band to access to the swimming area; it is obligatory.

Unless the client expresses its refusal, the campsite takes the right to use photos and pictures of its clients for commercial supports.

It is the client's charge to subscribe a public liability insurance and insurance for his equipment, tent or caravan.

The campsite is not responsible in case of thief, loss or any damage caused during or after the stay.

In case of litigation and after contacting the customer service of the Beaulieu, any client of the campsite has the possibility to submit a consumer mediator in a delay of one year from the date of the written demand to the management.
