

RULES AND REGULATIONS CAMPING BEAULIEU

(Decreet n° 2014-138 of 17 February 2014, J.O. of 19)

1°- Admission Requirement

To be allowed to penetrate, to remain and to settle in the campsite, it is necessary y to be authorized by the manager or his representative. He has an obligation to take care of the good behaviour and the good order of the campsite, like with the respect of the application of these rules of procedure.

The fact of remaining with the campsite "BEAULIEU" implies the acceptance of the provisions of these rules and the commitment to conform to it.

No one can take up residence in the campsite.

2°- Formalities

Minors are allowed to settle presenting a written authorization of their parents and must be accompanied by a person over the age of majority on the same pitch.

In application of article R.611-35 of "code d'entrée et du séjour des étrangers et du droit d'asile", the manager has to give the client of a foreign nationality an individual form of police, at his arrival. It must mention:

- The name and first names
- The date and place of birth
- The nationality
- The address of domiciliation

The children under 15 years old can figure on one of their parent's form.

3°- Installations

The office is situated at the entrance of the campsite 3 rue du Treuil Gras. The hours of opening change according to the season. They will be posted on the noticeboard, at the entrance of the office and on the website. You will find at the office all the information on the services of the campsite the BEAULIEU ****, information on the possibilities of supply, the sporting installations, the tourist richness's of the surroundings and various addresses which can be useful.

A register intended to receive complains and suggestions is at your disposal at the office.

5° - Bill posting

These rules and regulations are posted at the entrance of the campsite and at the office. It can be given to any client claiming it.

For the campsites which are classed, the category of the class with the tourism or leisure mention and the number of tourism or leisure pitches are stated.

The prices of the different extras are communicated to the clients in the conditions fixed by the decree of Minister charged of the consummation and available for consultation at the office.

6° - Mode of departure

The clients are invited to prevent the office if they have to leave the day before. The clients who want to leave before the opening of the office must do the day before at the latest, the payment of their dues.

7° - Noise and silence

The campers are urged to avoid all noises and discussions which could obstruct their neighbours. The sound apparatuses must be regulated consequently. Closing of doors and trunks must be as discrete as possible.

The dogs and other domestic animals should never be left in freedom. They should not be left in the campsite, even locked up in the absence of their masters who of it are civilly responsible.

Visitors entering the campsite with motorcycles and scooters are urged to stop the engine at the entrance for the other clients' respect.

The manager asks the **silence to be total from midnight and 7a.m.**

Dangerous behaviours, disturbance of other people and on site, noise and public drunkenness will lead to the non-continuation of the contract.

8° Visitors

After being authorized by the manager or his representative, the visitors can be allowed in the camp site under the responsibility for the tenants who receive them.

The camper can receive visitors at the office. If these visitors are allowed to penetrate in the ground, the camper who receives them can be held to discharge a royalty, insofar as the visitor has access to the services and/or installations of the campsite. This royalty is the subject of one posting to the entry of the campsite and the reception.

The visitors' cars are forbidden inside the campsite.

9° - Circulation and parking of the vehicles

A gate is installed at the entrance and at the exit of the campsite.

The access inside the campsite can be done only after using a code given by the office at the arrival. Each code is strictly personal and has to be used both at the entrance and exit.

In the campsite, vehicles must run at 10 km/h maximum.

Circulation is prohibited between 11 p.m and 7 am

Can circulate in the campsite only the vehicles, which belong to the tenants remaining there. The parking, strictly prohibited on the sites usually occupied by the mobiles home, should not, moreover, block circulation, nor to prevent the installation of the newcomers.

Only one vehicle per pith will be tolerated.

The entrance gate is open from 7AM to 11PM. The parking inside the campsite will be tolerated in the night.

If you arrive after 11 PM or leave before 7 AM, parkings are at your disposal.

10° Behaviour and aspect of the installations

Each one is held to abstain from any action which could harm cleanliness, hygiene and the aspect of the campsite, and its installations, in particular sanitary blocs. It is forbidden to throw the worn water on the ground or in the gutters. The caravaneers must obligatory empty their worn water in the installations for this purpose in the sanitary bloc.

Rubbish, wastes, papers must be thrown in the containers are at your disposal.

Washing is strictly forbidden apart from the vats envisaged for this use.

The washing of the vehicles and caravans is strictly prohibited.

The spreading of clothes will be done with the common drier or in the room of sharpening, to dry the clothes (tokens to be withdrawn with the reception). However, it will be tolerated until 10h00 near the shelters, the strict condition that it is discrete and does not obstruct the other users; it will have never to be made starting from the trees.

The plantations and decorations must be respected. It is forbidden for the tenants to plant nails in the trees, to cut branches.

It is not allowed either to limit the site of an installation by average personnel, or to dig the ground.

Any degradation made on vegetation, the fences, the ground or the installations of the campsite will be the responsibility of its author.

The pitch which is used during the stay has to be maintained in the state in which the tenant or the caravaner found it the day of its arrival.

Washing machines and a dryer are at your disposal in the laundry (tokens on sale at the office).

11° - Security

a) Fire

Open fires (wood, coal, etc.) are rigorously prohibited on pitches.

Two collective barbecues are at your disposal (in front of the sanitary bloc and near the tennis court).

Camping stoves must be maintained in good operating conditions and not be used under dangerous conditions.

Only gas or electric camping stoves or barbecues are accepted.

In case of fire, warn the office immediately. The extinguishers are at the disposal of all.

A first-aid kit is at your disposal at the office.

b) Theft

The direction is responsible of the objects deposited at the office and has a general obligation of watching on the campsite. The client keeps the responsibility for his own installation and must announce to the person in charge the presence for any suspect person. Although guarding is assured, the users of the campsite are invited to take the usual precautions for the safeguard of their material.

12° Games

No violent or disturbing games can be organised near the installations.

The children club cannot be used for turbulent activities

The swimming pool area inside the campsite is only accessible for the clients. The access can only be done with the bracelet given at the arrival for each client.

Bermuda shorts and shorts are strictly forbidden.

A regulation is at your disposal at the swimming pool area.

Parents are responsible of their children.

13° Caravan storage

No unused material can be left on the campsite without the authorization of the manager and only on the place planned.

This extra is charged.

14° Animals

Animals of first and second categories are forbidden. Only cats and dogs (held on a leash), tattooed, vaccinated (rabies include) are accepted in a limit of one per rental or pitch. The vaccination card must be presented at the arrival.

For hygienic reasons and respect of all, the droppings made inside the campsite must be picked up.

It is forbidden to feed wandering cats and dogs.

15° Violation of the regulations

In the case a client would disturb the other clients or would not respect the present rules and regulations, the manager or his representative will be able orally or in writing, if he considers it necessary, give notice to stop the trouble.

In case of serious or repeated violation of these regulations and after formal notice, the contract can be terminated.

In case of penal violation, the manager can call police force.

In case of litigation and after informing the customer service of the campsite, every customer has the possibility to take to mediation of consumption, in a delay of one-year maximum departing from the date of the written complaint by recorded delivery to the campsite.
