## GENERALITIES AND BOOKING

Each booking request implies having taken knowledge of the description of the subject and the price and also the agreement of the rules and regulations of the campsite and its general conditions. Each rental contract is personal and retrocession to a third part is not possible. The booking proposal is subject to the availabilities at the day of the contract sending. The management is not engaged in any other way. The booking form must be correctly completed and sent quickly with the request deposit, booking fees and cancelling insurance if subscribed. The booking becomes effective after a written confirmation of the management and at the reception of the 30% deposit. It will be confirmed and accepted. Every change must be notified one month before the arrival. Your arrival form must be presented at the reception on arrival day. It is your responsibility to subscribe a civil liability insurance, as well as an insurance for your material, tent, caravan. Campsite Le Beaulieu is not responsible in case of thief, loss or any damage, during or after your stay.

Prices are including VAT, with a tax rate of 10% % practical the day it was defined. Each later change of the VTA rate that occurs between the moment the prices have been determinate and the billing of the stay, will lead to a correlative change of the price including VTA, which the client accepts unreserved.

No refund of the stay will be accepted if the rules and regulations is not respected (noise, dangerous behavior, drunkenness, disturbance of other customers' tranquility ...)

No installation will be accepted on the pitch except after agreement of the management implying an extra payment.

Each customer must take note of the rules and regulations available on demand and posted at the reception and at the entrance of the campsite.

### ARRIVAL AND DEPARTURE

Pitches: from 2PM departure before noon.

Accommodations: from 3 PM departure before 10AM

On arrival, the campsite has the right to cancel the stay ad to refuse the access to the campsite if the number of participants is superior to the indicated number maximum of people accepted (accommodation according to the

range and pitches up to 6 people) No refund will be accepted.

In case of arrival after the closing of the reception, it is up to the client to inform the office. The procedure will then be explained. For accommodations, the guarantee will have to be made before the arrival and before the closing of the office. Without news and if the booking is not complete, the client will be authorized to access the pitch the next morning only.

Departures after the indicated hours (noon for the pitches and 10 AM for accommodations,) will generate an extra night cost.

Early departures will not lead to a refund.

Pitches are rented per night and accommodations for at least 2 nights (according to the period, these minimum periods can change. In high season, a week is required for accommodations, from Wednesday to Wednesday or from Saturday to Saturday.

### PAYMENTS

**DEPOSIT** 30% of the stay + 18 € of booking fees + cancelling insurance (if subscribed).

**BALANCES EVERY BALANCE IS TO BE PAIED ONE MONTH BEFORE THE ARRIVAL DATE WITHOUT REMINDER OF THE CAMPSITE.**

If the balance is not paid in the required date, the campsite has the right to cancel the booking and will inform the client. The deposit will not be refund. Balances can be paid by credit OR bank transfer only. If the arrival is planned less than one month after the boking, the entire amount will be required.

### GUARANTEE AND INVENTORY

A guarantee of 260 € will be required on arrival for accommodations. 185 € to cover damages and breaking and 75 € for cleaning. This guarantee is cancelled at most one week after the departure after the checking of the accommodation. The guarantee is made by credit card. It is not cashed. On arrival, you have to fill the inventory and return it to the office at most the morning after arrival. If it not returned at this fixed delay the previous inventory will be taken.

### LATENESS, CANCELLING, INTERRUPTION OF THE STAY

In case of lateness and without news more than 24hours after the planned date of arrival, the management is in right to make the pitch available again. No refund will be done.
